

## Terms of Service:

The following terms and conditions govern all use of the Botox Training Club website and all content, services and products available at or through the website (taken together, the Website). The Website is owned and operated by Botox Training Club ("Botox Training Club"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Botox Training Club Privacy Policy) and procedures that may be published from time to time on this Site by Botox Training Club (collectively, the "Agreement").

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement. If you do not agree to all the terms and conditions of this agreement, then you may not access the Website or use any services. If these terms and conditions are considered an offer by Botox Training Club, acceptance is expressly limited to these terms. The Website is available only to individuals who are at least 13 years old.

**1. Botox Training Club Account and Site.** If you create a blog/site on the Website, you are responsible for maintaining the security of your account and blog, and you are fully responsible for all activities that occur under the account and any other actions taken in connection with the blog. **2. - your blog is not Botox Training Clubd in a manner that misleads your readers into thinking that you are another person or company. For example, your blog's URL or Botox Training Club is not the Botox Training Club of a person other than yourself or company other than your own; and
- you have, in the case of Content that includes computer code, accurately categorized and/or described the type, nature, uses and effects of the materials, whether requested to do so by Botox Training Club or otherwise.

### **3.Payment and Renewal.**

## **General Terms.**

By selecting a product or service, you agree to pay Botox Training Club the one-time and/or monthly or annual subscription fees indicated (additional payment terms may be included in other communications). Subscription payments will be charged on a pre-pay basis on the day you sign up for an Upgrade and will cover the use of that service for a monthly or annual subscription period as indicated. Payments are not refundable.

## **Automatic Renewal.**

Unless you notify Botox Training Club before the end of the applicable subscription period that you want to cancel a subscription, your subscription will automatically renew and you authorize us to collect the then-applicable annual or monthly subscription fee for such subscription (as well as any taxes) using any credit card or other payment mechanism we have on record for you. Upgrades can be canceled at any time by submitting your request to Botox Training Club in writing.

## **4.Services.**

•**Fees; Payment.** By signing up for a Services account you agree to pay Botox Training Club the applicable setup fees and recurring fees. Applicable fees will be invoiced starting from the day your services are established and in advance of using such services. Botox Training Club reserves the right to change the payment terms and fees upon thirty (30) days prior written notice to you. Services can be canceled by you at anytime on thirty (30) days written notice to Botox Training Club.

**Support.** If your service includes access to priority email support. "Email support" means the ability to make requests for technical support assistance by email at any time (with reasonable efforts by Botox Training Club to respond within one business day) concerning the use of the VIP Services. "Priority" means that support takes priority over support for users of the standard or free Domain Botox Training Club services. All support will be provided in accordance with Botox Training Club standard services practices, procedures and policies.

**14.Termination.** Botox Training Club may terminate your access to all or any part of the Website at any time, with or without cause, with or without notice, effective immediately. If you wish to terminate this Agreement or your Domain Botox Training Club account (if you have one), you may simply discontinue using the Website. **18. Indemnification.** You agree to indemnify and hold harmless Botox Training Club, its contractors, and its licensors, and their respective directors, officers, employees and agents from and against any and all claims and expenses, including attorneys' fees, arising out of your use of the Website, including but not limited to your violation of this Agreement.

**19. Except for claims for injunctive or equitable relief or claims regarding intellectual property rights (which may be brought in any competent court without the posting of a bond), any dispute arising under this Agreement shall be finally settled in accordance with the Comprehensive Arbitration Rules of the Judicial Arbitration and Mediation Service, Inc. ("JAMS") by three arbitrators appointed in accordance with such Rules. The arbitration shall take place in Arbitration Location, in the English language and the arbitral decision may be enforced in any court. The prevailing party in any action or proceeding to enforce this Agreement shall be entitled to costs and attorneys' fees. If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms and conditions; Botox Training Club may assign its rights under this Agreement without condition. This Agreement will be binding upon and will inure to the benefit of the parties, their successors and permitted assigns.

## **Privacy Policy:**

Full Botox Training Club ("**Botox Training Club**") operates Domain Botox Training Club and may operate other websites. It is Possessive Botox Training Club policy to respect your privacy regarding any information we may collect while operating our websites.

### **Website Visitors**

Like most website operators, Botox Training Club collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Possessive Botox Training Club purpose in collecting non-personally identifying information is to better understand how Possessive Botox Training Club visitors use its website.
